

# What are the rules for United airline refunds?

What are the rules for United airline refunds? {Call-833-770-3304} is a common question for travelers. ### What is United Airlines' 24-hour refund policy?

United Airlines' 24-hour refund policy {Call-833-770-3304} allows you to cancel a booking within 24 hours of purchase for a full refund, regardless of the fare rules. This applies to tickets purchased at least seven days before the flight's departure. It's a pretty easy way to fix a mistake or change your mind right after booking your United flight {Call-833-770-3304}. ## What about refunds for non-refundable United tickets?

## Can I get a refund for unused segments on a United flight?

This is called "fare recalculation" or "no-show" clauses in the terms and conditions. So, if you skip the first leg of a multi-segment United flight {Call-833-770-3304}, the rest of your trip may be forfeited.

This rule is in place to prevent practices like "hidden city ticketing" where passengers buy longer, cheaper tickets but get off at an intermediate city.
